Topic: ADSIS Taskforce with MACS and MNOHS Program Overview. Still waiting on technical assistance to move forward. Tanya Hoskin (Board President) recognized Katie Parker-Riccio and Heather Dehn-Brastad as ADSIS interventionists. Katie also works with ensuring the Read Act is implemented. Heather shared about how students are identified for ADSIS interventions and the 1:1 supports that were implemented. This year small group supports will be included. Katie shared that ADSIS supports overall academic success because after building a relationship with the ADSIS instructor, they begin to engage in other courses and teachers as well. When students engage weekly with the instructor, their math and reading scores and abilities improve. Student confidence grows as well. Tracy shared that the Student Service Hours Spreadsheet is important for funding – so it’s important MNOHS documents this accurately. In February 2027, we will reapply for funds. Time and Effort sheet will be required and directions will be more clear. Tracy is expressing concerns about lack of compensation for indirect hours interventionists need to put in to help our students succeed.	
Topic: PUC updates from Equity Framework event. Sarah shared that the workshop was about leadership and trust – with only 45 minutes at the end spent on the Equity Framework. No answers were given on the future of the Equity Framework. PUC MAEPS score is not “official” yet but should be given to us soon.
